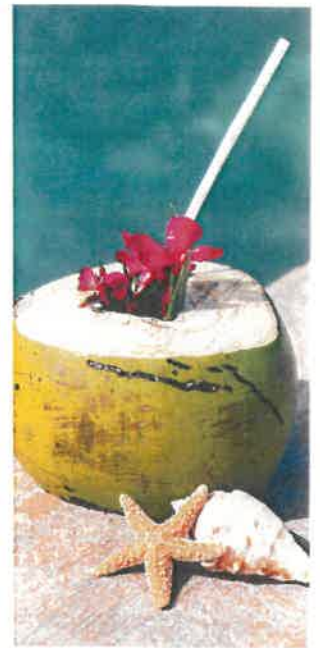

## **Deposit and Final Payment**

A deposit is due upon booking and to secure your reservation. Final payment is due on or before November 1, 2025.

## **Travel Protection**

Travel Protection is not required but is highly recommended. Our preferred travel protection partner, Travel Insured, offers comprehensive coverage for domestic & international travel - Please Note: Medicare & most supplement insurance policies DO NOT provide medical coverage outside of the United States. For a quote &/or additional information on travel protection options, please contact Travel Insured directly. Travel Protection MUST be purchased within 14 days of trip deposit.

## **Airline Requests & Seats**

Traveler/Security Information (TSA/KTN numbers, Frequent Flyer numbers, etc) and Special Requests (medical, dietary, etc) will be forwarded to the airline at the time of ticketing. It is the traveler's responsibility to reconfirm these requests directly with the airline upon airport check-in. All seats are assigned at the airline's discretion. Travelers with the same last name are typically seated together; however, World of Travel has no control over final seat assignments. In-Class seat changes/upgrades (i.e., Preferred Seats) are to be confirmed by the traveler(s) directly with the airline, after ticketing is complete (30-60 days prior to departure). Class upgrades must be requested prior to Final Payment. NOTE: If booking flights using Frequent Flyer Miles, the traveler(s) must purchase their tickets directly from the airline. In this instance, an air credit will be applied to the traveler(s) final payment invoice. Air credits vary per trip.

## **Cancellation Schedule**

All cancellations must be received in writing. Cancellations received before the final payment date are subject to an administration fee of \$100 per person. Cancellations received after the final payment date are non-refundable.

## **Travel/Health Policy**

It is required that persons needing assistance be accompanied by a companion who is capable and totally responsible for providing that assistance. Neither World of Travel nor its suppliers may assist with medications, wheelchairs, or physically lift persons onto transportation vehicles. Travelers having special needs must notify World of Travel when they make their reservations. Please note that the Americans With Disabilities Act does not apply outside the United States.
