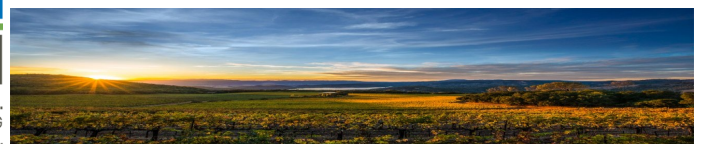

Sample Itinerary

Day 1 - Motorcoach Transportation is included to Detroit Metro Airport. Fly to **Seattle**. **Dinner included** tonight. Lodging at **Hampton Inn Downtown**.

Day 2 - A **sightseeing tour of Seattle** highlights our morning. Visit **Pike Place Market**, considered Seattle's heart and soul. This afternoon visit **Mt. St. Helen's Visitor Center**. The Center features walk through interpretive exhibits and award-winning theatre programs to educate the visitor on the tale of events that lead to the 1980 eruption. Arrive in **Portland, the "City of Roses"** for **(2) nights**. Lodging at **AC Courtyard by Marriott - Portland - City Center Downtown**.

Day 3 - Visit **Timberline Lodge**, famous as the setting in the movie *The Shining*, situated on the vast slopes of 11,290-foot Mt. Hood. Take a tour of the lodge. Proceed down the scenic Hood River Valley to the Columbia River and the Bonneville Dam and Lock. See the salmon ladders and learn about the impressive lock system. Our last stop is **Multnomah Falls**, a waterfall as magnificent as any in the country. At 611 feet, the roaring cascade of water allows you to experience the power and beauty of nature up close. **Dinner included**.

Day 4 - Oregon has over 200 state parks, most of which are along the dramatic coast. Oregon's coastline is made up of diverse terrain that changes from rugged cliffs to evergreen forests to Sahara-like dunes to boundless sandy beaches. Traveling south we'll pass breathtaking coastal scenery, scores of quaint towns, historic lighthouses and stunning viewpoints. Arrive in **Newport, Oregon** for a mid-day **whale watching cruise**. See the massive Gray whale which reach 45 feet in length, the same as our motorcoach. Check into the **Hallmark Resort**, a 1st class **oceanfront hotel**. Your **guest room overlooks the Pacific Ocean**. (www.hallmarkinns.com)

Day 5 - Head south to **Florence, Oregon**, home of the magnificent **Oregon Sand Dunes**, some of which reach heights of 300 feet. Enjoy a thrilling **dune buggy ride** an exciting tour that takes us over the dunes and also takes us on a leisurely ride right on the beach of the Pacific Ocean. Stop at **Heceta Head Lighthouse**, which was built in 1894 and is listed on the National Register of Historic Places. From a height of 205 feet above the ocean, it casts it's beam 21 miles out to sea. Located right on the coast, it is one of the most photographed lighthouses in the United States. This afternoon head to **Grants Pass, Oregon** for the night. **Lodging right on the Rogue River**, the perfect location for our thrilling **jet boat dinner cruise** on the river.

Day 6 - Continue south into California along the stunning coastal route to **Redwood National Park**. To someone who has never seen one, a Redwood must seem to be something from a tall tale. See trees taller than the Statue of Liberty and larger around than a motorcoach. Hop aboard the "**Sky Gondola**" for a once-in-a-lifetime gondola ride through "**The Trees of Mystery**". **Overnight in Eureka, California**.

Day 7 - Explore the **Avenue of the Giants**, and walk among these giants. Continue south traveling through the picturesque **Sonoma Valley's** rolling hillside and wineries. The Valley is nestled between two mountain ranges offering exquisite and peaceful beauty. Our home for the next two nights is the **Cambria Suites in Napa, CA**. This evening at your leisure explore **Oxbow Marketplace** and downtown Napa, an eclectic downtown with shops, pubs, boutiques, restaurants with a cool California vibe.

Day 8 - A **guide joins us today** as we explore **Napa Valley, one of the world's premier wine regions** boasting more than 400 wineries. This iconic wine region features breathtaking scenery, a rolling landscape and charming small towns with so much character. We'll visit **(2) Napa Valley wineries** for tasting and enjoy an **included casual lunch** at **Gott's Roadside Café**. Dinner and evening at your leisure.

Day 9 - Head to San Francisco for our flight home.
